Current rules in Romania regarding the SARS-CoV-2 pandemic for organizing training courses and workshops for adults and for entrance of the foreign citizens

According to the government decision no. 38 of 09.06.2021, paragraph 27 allows the organization of training courses and workshops for adults, including those for the implementation of projects financed from European funds, with the participation of maximum 70 people indoors and a maximum of 200 people outdoors, with the assurance of a 2 square meters' area for each person, wearing a protective mask and in compliance with the public health rules established by order of the Romanian Ministry of Health.

The number of participants can overpass 70 people if the participants at the event are vaccinated against the SARS-CoV-2 virus for which 10 days have passed since the completion of the complete vaccination schedule.

All these are valid if the cumulative incidence at 14 days in the county / locality is less than or equal to 3 / 1,000 inhabitants.

According to the government decision no. 35 of 29.05.2021, for foreign citizens and stateless persons arriving in Romania from third countries, the quarantine measure is established for a period of 14 days regardless of the area in which the country from which they arrive is framed, with the following exceptions:

- a) persons vaccinated against the SARS-CoV-2 virus and for whom 10 days have elapsed since the completion of the complete vaccination scheme until their entry into Romania;
- b) persons who have been confirmed positive for SARS-CoV-2 virus infection in the last 90 days prior to entry into the country, as evidenced by medical documents (positive RT-PCR test at the time of diagnosis, hospital discharge ticket or test to prove the presence of IgG antibodies performed with a maximum of 14 days prior to entry into the country) or by checking the Corona-forms database and for which at least 14 days have elapsed from the date of confirmation to the date of entry into the country;
- c) children under 3 years of age or older, without the need to present the negative result of an RT-PCR test for SARS-CoV-2 virus infection;
- children over 3 years of age and under 16 years of age, if they show a negative RT-PCR test for SARS-CoV-2 virus infection, performed no more than 72 hours before boarding (for those traveling with means of public transport) or entry into the national territory (for those traveling by their own means);
- e) persons who come to Romania from countries / territories of epidemiological risk but who, before arriving in Romania, have spent the last 14 consecutive, consecutive days in one or more countries / territories without epidemiological risk;
- f) persons entering Romania for activities of use, installation, commissioning, maintenance, service of equipment and technology in the medical, scientific, economic, defense, public order and national security, transport, as well as persons carrying out specific professional activities in the fields mentioned, if they prove the contractual / collaboration relations with

the beneficiary / beneficiaries on the Romanian territory, as well as the inspectors of the international bodies;
